## Bidding process for interruptible storage product from

## Trianel Gasspeicher Epe GmbH & Co. KG

## Auction date and time 17. June 2021 14:00 (CET)

Trianel Gasspeicher Epe GmbH & Co. KG (TGE) brings again storage capacities on an interruptible basis to the market. For the period from 1 April 2022 to 1 April 2023, a total of 3 identical stored bundles will be marketed. Each stored bundle consists of 35,000 MWh of working gas volume, 200 MWh of injection capacity and 400 MW of withdrawal capacity. **The deadline for the bidding process is 17 June, 14:00 CET**.

The following information must be included for a bid to be considered complete:

- a. Company name
- b. Contact
- c. Company address
- d. Bid price

Bidders can bid for one, two or three bundles. Bidders that bid for two or three bundles are free to offer different prices for the bundles.

The bids for the individual bundles must be stated separately and in €:

- e. Date and signature
- f. Company stamp

The bid submitted is a binding declaration of intent by the bidder to conclude a contract. TGE reserves the right to assess the bidders' creditworthiness. On request, the bidder shall provide TGE with all information required to assess its creditworthiness, in particular up-to-date balance sheet/annual financial statement data or an existing profit and loss transfer agreement on request. If the bidder does not comply with a request of this kind in good time, TGE is entitled to exclude the bidder's bid from the remainder of the process.



TGE is entitled but not obliged to accept one of the bids submitted within 2 hours from the end of the offer period of the bidding process. The capacities will be allocated on a non-discriminatory basis according to price but TGE reserves the right to refrain from any contract if the offers submitted do not correspond to their price expectations.

#### Variable storage fee for Injection (Arbeitspreis)

Analogue to the variable storage fee for injection pursuant to the "Appendix D " Product and Price List of the General Terms & Conditions for Access to the Gas Storage Facility of Trianel Gasspeicher Epe GmbH & Co. KG (Version 2020/04)" and the reference gross calorific value which is published on the TGE-website (www.trianel-gasspeicher.com). The variable storage fee for injection for the storage year 2020/2021 amounts to 0,00435 Euro/m³ / 11,42 kWh/m³ = 0,37 €/MWh. The discount of "support anticyclical use of the storage products" analogue "Appendix D – Product and Price List" lit. c 2. paragraph of the General Terms & Conditions (Version 2020/04) will be granted. Therefore the variable storage fee for injection will be actually from 01/04/2021 – 01/05/2021 and from 01/11/2021till the 01/04/2022 0,185 €/MWh.

The variable storage fee for injection will be adjusted annually in accordance with the price adjustment mentioned in "Appendix D – Product and Price List of the General Terms & Conditions (version 2020/04). The first price adjustment will take place on 01 April 2022. The 2019 calendar year will be the base year for the index values shown in the escalation formulas. When TGE is offering a variable storage fee for injection in "Appendix D Product and Price List of the General Terms & Conditions" for its Storage customers, which is lower compared to the fee resulting when the price adjustment, the Customer of the Residual Product will also participate in the lower variable storage fee for injection. The applicable General Terms & Conditions are published on the TGE website (www.trianel-gasspeicher.com). The Customer of the Residual Product will be informed of each change of the variable

storage fee for injection or the reference gross calorific value.		
Minimum bid	TGE only considers bids above the minimum price, which is not published.
